ADDITIONAL COMPENSATION PROGRAM

For agents with groups who currently have a carrier that may be exiting the group health insurance market.

Agents have advised us that some of their customers are concerned that their current carrier may be exiting the group health insurance market. UnitedHealthcare is prepared to assist agents who, in direct response to customer request, move their concerned customers to UnitedHealthcare or UnitedHealthcare subsidiary fully insured, level-funded and self-funded group medical products. A one-time additional compensation payment per enrolled employee will be made to agents who enroll such customers with UnitedHealthcare or UnitedHealthcare subsidiaries from April 1, 2024, through, Dec. 31, 2024, according to the following table:

BONUS FOR EACH FULLY INSURED AND LEVEL-FUNDED ENROLLED EMPLOYEE	BONUS FOR EACH SELF-FUNDED ENROLLED EMPLOYEE
\$60	\$20

Groups eligible for the additional compensation are medical groups with up to 3,000 eligible employees in eligible states that move directly from a carrier that may be exiting the group medical insurance market to UnitedHealthcare or UnitedHealthcare subsidiary fully insured, level-funded or self-funded group medical products with effective dates from April 1, 2024, through Dec. 31, 2024. The additional compensation will be paid based on the Dec. 31, 2024, enrolled employee count of the eligible groups.

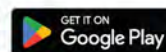

**OPEN ENROLLMENT PERIOD
(OEP) IS HERE!**

JANUARY 1ST — MARCH 31ST

- Open Enrollment for Medicare Advantage plans runs from January 1st, up through March 31st, for effective dates of February 1st to April 1st.
- Open Enrollment Period (OEP) is only available for beneficiaries who are currently enrolled in a Medicare Advantage plan. This is not an enrollment period for a beneficiary to enroll in a Medicare Advantage plan for the first time.
- The same submission rules apply – paper applications must be submitted to the carrier within 48 hours of client signature. Applications can also be entered online thru the carrier website.

Changes that can be made for the Medicare Advantage Open Enrollment Period (OEP)

- Beneficiaries can switch from one Medicare Advantage plan to another Medicare Advantage plan.
- Beneficiaries can make a one-time election to drop their Medicare Advantage plan and return to Original Medicare – Part A and B. With this change, beneficiaries can sign up for a stand-alone Medicare Part D Prescription Drug Plan. Usually a Medicare Advantage Plan includes drug coverage and once signed up for a Part D Prescription Drug Plan, it will drop the beneficiary from the Medicare Advantage Plan and return them to Original Medicare Part A and B. New coverage will start the first of the month following the month that the change was made. They can then enroll in a Medicare Supplement plan. In some cases, they may have to answer health questions to qualify.
- OEP is not a valid enrollment period for Medicare Cost Plans nor is it a valid enrollment period for someone to change stand-alone Prescription Drug plans.

SEP - Declared Disaster/Emergency

FEMA has declared a weather-related emergency or major disaster in our area. This means Medicare beneficiaries residing in the affected area may be eligible for a Special Election Period (SEP).

- For paper, use the SEP election type code & write in Weather Related Emergency
- For LEAN, please select the SEP Declared Disaster/Emergency reason code.

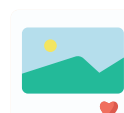
