Not only is this a great opportunity for retired employees, the eligibility extends to spouses as well. All you need is a group of 1 - as long as they are a valid group per Wellmark's guidelines.

The group does NOT have to offer Wellmark group coverage to implement this program. Even if you aren't their agent of record, you can still offer them EGRP.

EGRP offers composite rates for all members and offers different billing options including direct bill to the client or a list bill to the group.

## Individual Marketplace 1095-A Tax Forms Are Now Available

Anyone enrolled in a Marketplace plan in 2020 will get a 1095-A tax form. Forms should be received by mail no later than mid-February, but can be accessed now through either Healthcare.gov or, if you utilize HealthSherpa, through your HealthSherpa account. Marketplace enrollees will need this form to file their 2020 taxes. If enrollees do not reconcile tax credits received for 2020, they could lose tax credits they are receiving for Plan Year 2021.

## Aetna Medicare Supplement rate adjustment in Iowa

Individual Medicare Supplement policies (ACC/AHIC\*) currently available in Iowa will have a rate adjustment effective March 1, 2021.

#### **Rate Adjustments**

New Business Guidelines for Medicare Supplement Rate Adjustments (Open Block) on Medicare Supplement plans underwritten by:

- Accendo Insurance Company (ACC), part of the CVS Health® family of companies and Aetna affiliate
- Aetna Health and Life Insurance Company (AHLIC)
- •Aetna Health Insurance Company (AHIC)
- American Continental Insurance Company (ACI)
- Continental Life Insurance Company of Brentwood, Tennessee (CLI)

The date the applicant signs an application (application signature date) AND the policy effective date determine which rates to apply to your new business. Instructions on how to apply a rate change to NEW applications are provided in the table below.

All currently marketed Aetna Medicare Supplement plans offer a 12-month rate guarantee. For existing policyholders affected by a rate adjustment, the change will become effective on the policyholder's next policy anniversary date that occurs on or after the rate change effective date. Rate change notices are sent to existing policyholders in accordance to the state's policyholder notification period.

Please note that the Outline of Coverage on Aetna Quote & Enroll will not have the revised rates until approximately 30 days before the rate change goes into effect. You can access the revised Outline of Coverage in the following table.
